

# Rental Requirements & Application to Rent

#### **Initials**

\_\_\_\_\_ A <u>non-refundable</u> application fee of \$60.00 is required of each adult applicant over the age of 18 years old and must be paid at the time of submitting application. At no time is cash payment accepted.

\_\_\_\_\_ Each adult applicant must submit a fully completed, dated and signed application. Each applicant is required to provide proof of identity at the time of signing the lease.

\_\_\_\_\_ Applicant must have a gross income of at least three times the monthly rent. A minimum of two years residential rental history is required.

\_\_\_\_\_ Credit history and/or Civil Court Records must not contain slow pays, judgments, eviction filing, collections, liens or bankruptcy within the past 5 years. Criminal records must contain no convictions for felonies within the past 7 years and no sexual offenses. We will not provide you with the credit report or tell you of its content instead you will be provided with the name of the credit reporting agency in order to receive a free copy of your credit report.

\_\_\_\_\_ Applicants who are self-employed are required to produce 2 years of tax return or 1099s upon request and non-employed applicants must provide acceptable proof of income.

\_\_\_\_\_ Previous rental history reports from landlords must reflect timely payment, sufficient notice of intent to vacate, no complaints regarding noise, disturbances or illegal activities, no NSF checks, and no damage to property or failure to leave the property clean.

\_\_\_\_\_ No pet (with the exception of medically necessary pets) of any kind is permitted without specific written permission of the landlord in the lease or in an addendum to the lease with a <u>Non-refundable pet deposit</u> acceptable to the landlord. The following breeds are not allowed: German Shepherd, Doberman, Pit Bull or Pit Bull mix, Staffordshire Terrier, Chow, Rottweiler, Siberian Husky, Akita, Malamute, Presa Canario and Wolf-Hybrid.

\_\_\_\_\_ Security deposit is the same amount as the monthly rent. However, we reserve the right to require a higher deposit.

\_\_\_\_\_ An application <u>"reservation deposit"</u> fee is required in the amount of one month's rent in the form of a cashier's check or money order in order to hold a property and to remove it from the market. In the event the application is approved and applicant fails to enter into a lease or move in on the agreed upon date, the reservation deposit fee will be retained as liquidated damages. Otherwise, the application reservation deposit fee will be credited towards payment of the first month's rent. In addition, all last month's rent if required, security deposit, and pet deposit must be paid prior to move-in by money order or cashier's check.

\_\_\_\_\_ Any exceptions to these criteria must be submitted in writing for the landlord's review and consideration. If approval is granted for such exceptions, additional security, and/or additional advanced rent payments may be required.

\_\_\_\_\_ Eaton Realty Services company policy is to report all non-compliances with the terms of your rental agreement or failure to pay rent, or any amounts owed to the credit bureaus.
